No new updates as of yet about project expansion efforts.

Project Pineapple

At the request of the site selection consultant, Mr. Harper continues to assist in the facilitation of a business development luncheon on behalf of Project Pineapple. This luncheon includes business and industry from throughout the region. The luncheon is scheduled for January 23.

Other projects

Mr. Harper is assisting Mr. Coughlin in developing the Southeast Submarine Suppliers Event on behalf of Electric Boat. The event is tentatively scheduled for May 2, 2019 on Jekyll Island, Georgia.

Mr. Harper continues to coordinate repairs and improvements to 121 Industrial Drive building and site for ABL Space Systems.

Mr. Harper participated in a meeting between Wildlife Defense Systems and the owners of the Read's Moving and Storage Building. The building owners and brokers are working with the company and their agents on a potential lease of space at the building.

Mr. Harper continues to facilitate meetings with large acreage property owners and a real estate broker from Atlanta who is seeking to gain control of a site on behalf of a project he and his investment partner are working. The broker has already secured a site in Atlanta, but he is also seeking to secure a site in Coastal Georgia.
