Camden County Joint Development Authority Project Manager's Report as of 7 November 2019

Mr. Harper assisted the City of Kingsland in the revision and reauthorization of the Kingsland Enterprise Zone Ordinance. Mr. Harper also prepared an Enterprise Zone ordinance for the City of Woodbine. The City is reviewing the ordinance. Mr. Harper offered to attend the city council meeting once the city is ready to vote on the issue.

Mr. Harper assisted Mr. Coughlin with the site visit for Project Nina. Mr. Harper also revised the incentive offering letter to Project Nina based on guidance from Mr. Coughlin.

Mr. Harper worked with Mr. Coughlin as well as Thomas and Hutton to complete a Request for Information (RFI) for Project Emerald. Georgia Power Project Managers along with Project Managers from the Georgia Department of Economic Development made contact with the Authority due to this project looking for sites located near ports.

Mr. Harper met with Mr. Robbie Cheek to discuss planning issues related to the Hutchins Tract and the Kingsland Commerce Park site.

Mr. Harper presented information on the efforts of the JDA along with industrial sits in Camden to the Camden GOP women organization.

Mr. Harper attended the Rural Prosperity Summit in Tifton, Georgia hosted by the Georgia Chamber of Commerce. In Tifton, Georgia.

Mr. Harper provided information on Kingsland economic development zones and incentives to a development group looking at a acquiring a hotel site at Exit 3.

Mr. Harper participated in a conference call with USDA Rural Development officials to discuss the Rural Business Development Grant. Mr. Harper is currently securing data and developing a scope of work to secure USDA RD grant support for a retail business study of the Camden market.

Mr. Harper completed the coordination of new for sale signs at available sites in the Camden County Industrial Park.
